The City of Clarksdale is seeking proposals from a qualified security guard company to provide security guard services at the front door of City Hall, 121 Sunflower Avenue, Clarksdale, MS.

The service prevents unauthorized access to certain offices.

The service will remain at a fixed point (front door of City Hall) to observe activities.

The service will require everyone from the public to sign in before entering and sign out when exiting the building.

Security Guard shall have knowledge of security techniques and practices associated with security issues.

Security Guards shall possess valid credential evidencing that they are employed by the Security Guard Company. These credentials must be in the possession of the guard at all times and must be presented at any time to any law enforcement officer or City representative.

Security Guards shall wear uniform as another form of evidence that they are employed by the Security Guard Company.

The City reserves the right, at its sole discretion, to refuse the services of any particular guard.

The Security Guard shall have comprehensive standards of appearance for maintaining both professional standards of conduct and neat personal appearance for its employees.

The service shall provide all labor, material, supplies and equipment and shall plan, schedule, train, coordinate and ensure the effective performance of all services.

The service shall provide regular hours of service: Monday through Friday 8:00 a.m. to 5:00 p.m., normal business days excluding holidays.

The Security Guard Company shall be fully responsible for the direct supervision of its employees but shall provide an overall Supervisor as a point of contact for the City.

The Security Guard Company is required to have a minimum of \$500,000 liability insurance and workers comp coverages for its employees.
